Overview:

We're WWT, the charity for wetlands and wildlife. We're on a mission to restore wetlands because they are a wondrous solution to the problems our world faces. Together we will unlock their power – and help nature burst back to life. Because when wetlands flourish all life will flourish.

At WWT our people are instrumental, and we want to inspire future conservationists to help lead the way. This learning and development placement is designed to provide experience and skills development in the following areas:

- Practical animal care experience, in a wetland setting
- Experience of the workplace
- Wetland conservation.

You'll work within the Living Collections team, developing practical animal care experience, and animal behavior and welfare knowledge. The role will involve the day-to-day care of the animals in the collection of rare and endangered species from around the world, including Flamingos, Cranes, Storks, Ducks, Geese, Swans and Otters. You'll maintain and develop exhibits within the site to improve welfare standards for our animals, and enhance the visitor experience, developing communication and presentation skills. As part of a BIAZA member zoological collection, this role is a great opportunity for someone looking for experience in animal or conservation-based roles.

This role is a 12-month fixed term contract.

Supervisory responsibilities: None

Responsibilities of the post

To achieve the main function of the post as set out above the post-holder will be:

1. Feeding presentation daily, feeding routines and creating animal enrichment
2. Cleaning animal houses, enclosures, rearing facilities, and ponds, ensuring they are in good repair
3. Undertaking animal census and recording of daily routines
4. Maintaining enclosures and ponds
5. Managing vegetation within enclosures and public areas
6. Maintaining and improving fence lines, shelters and buildings
7. Conducting public feeds, talks and guided tours
8. Interacting with visitors to provide excellent customer service
9. Assisting with animal handling, health checks and medication
10. Helping during the breeding season within a controlled breeding plan (nest box management, incubator operation and animal rearing)
11. Keeping record and welfare reporting
12. Assisting with pest management protocols and camera trap data

If you are required to carry out your own research project as part of your qualification, you will be supported to do so.

Working with Volunteers

1. To work alongside volunteers encouraging, developing and supporting them in their work for WWT, ensuring that they have a positive volunteering experience.

2. To be responsible for working within the WWT health and safety policy and guidelines ensuring that the health, safety and wellbeing of yourself and others is an integral part of how you work.

4. To interact with our visitors and supporters in a positive way, shaping unforgettable experiences and helping them understand and connect to wetlands.

5. To ensure that in the course of your work you adhere to the WWT Data Protection policy and standards.

Person Specification

1. Qualifications

Essential:

- A qualification (level 2 or higher) in a field applicable to the role or an equivalent level of experience

2. Experience and Skills

Desirable:

- Interested in practical animal care, with experience of carrying out husbandry tasks with a range of species
- Able to work in a team of staff and volunteers, and demonstrate good people skills
- Proactive and able to carry out tasks with a minimum of supervision or independently under direction
- Ability to follow instructions and safely complete activities
- Public speaking skills
- Ability to work outdoors in all weathers
- Driving licence

3. Managerial & Supervisory

- This post will have no managerial or supervisory requirements.

4. Responsibility

Desirable:

- Excellent self-management skills with ability to work independently, using own initiative and being flexible and adaptable
